This means you must initiate contact with your nominated supervisor/s to formulate, together, a research topic. The details of this express support and research plan/topic are to be included in this application.			
	You must also have express support from your SET head of home supervisor that they support this PhD/FRACS application. Include the name of the supervisor in the form below.			
	A maximum of one applicant per year will be accepted into the combined Plastic and Reconstructive Surgery PhD/FRACS program.

- Methods should directly relate to Aims
- Details relating to any human, animal or other ethics submissions that will be required, and when in the course of the PhD these will be obtained
- Details of statistical analysis to be used
- Location/s of primary clinical or experimental work, noting any issues relating to patients, equipment or other major factors
- Proposed timeline of clinical work and experimental work completion, again, in relation to Aims listed above
- Supervisor names and details
- Scholarship applications
- A very brief description of your academic and professional background (try limit to one paragraph)
